

Virgin Hotels “**BARRY’S x VIRGIN**” Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN.

A PURCHASE DOES NOT IMPROVE YOUR CHANCE OF WINNING.

**1. Eligibility:** To enter the Virgin Hotels “**BARRY’S x VIRGIN**” Sweepstakes (the “Sweepstakes”), you must be at least 21 years of age and a legal resident of one of the fifty United States or District of Columbia. 1. **How to enter:** During the Entry Period, you must visit [virginhotels.com/barrys](http://virginhotels.com/barrys) and follow the instructions to enter to win on the Virgin Hotels contest page (the “Website Entry Page”) by entering your valid email and clicking to opt in. By entering in your information requested on the Website Entry Page, including your name, e-mail, zip code, you acknowledge your intent to enter the Sweepstakes and your agreement to be bound by these Official Rules including the decisions of the Sponsor in all matters relating to this Sweepstakes. You must join The Know and complete your profile to be considered a valid entry.
2. **General Entry Conditions.** Limit one (1) Entry per person/valid email address or two (2) entries per person/valid email address for Barry’s Academy members. Entries will not be acknowledged or returned. In the event of a dispute over the

identity of an entrant. Proof of transmission/upload is not proof of receipt. Sponsor's computer is the official timekeeping device for the Sweepstakes. No responsibility is assumed for late or misdirected entries, or any failure or unavailability of hardware, software, electronic communications, or Internet uploading or other connections. Entry constitutes permission for Sponsor and its designees to use winner's name, biographical information, photo and/or likeness in any and all media, now or hereafter devised, worldwide, in perpetuity, for internal, advertising, promotion and other purposes without additional compensation, notification or permission, unless prohibited by law. The drawings will be conducted on or about February 28th, 2026. The Winners will be notified via email that was provided, to which he/she must respond and

provide his/her full name, street address, a valid email address and date of birth within seven (7) days of the initial notification attempt (regardless of when potential winner actually receives such notification). Thereafter, Sponsor will send potential Winners by mail or email (in Sponsor's sole discretion) an Affidavit of Eligibility and Liability/Publicity Release ("Prize Claim Forms").   - a 100 Class Package All-Access Class Credits gives the Member the ability to book a class at any Barry's Studio in the US, excluding Miami. Package retails for \$4,300. Credits are subject to Barry's Terms of Service. Credits will have a one year expiration from the date of redemption. Any unused credit (once redeemed on the Member's Barry's account) will expire after one year. Once applied to the Member's Barry's account, the class credit is non-transferable, non-refundable, and has no cash value. This prize may not be combined with any other promotions, discounts, or offers; and
  - a 2-night stay at any Virgin Hotels property in the US (excluding Las Vegas). The hotel stay certificate is valid for up to one (1) year for winner and one guest for a two (2) night stay in a "Grand Chamber King" room at any Virgin Hotels property in the US. Approximate retail value of hotel portion of prize ("ARV"): \$790 [Based on \$395/night x 2 nights]. If guest is under eighteen (18) years of age, winner must be guest's parent or legal guardian. Blackout dates and availability at the hotel and other terms and conditions may apply; and

- 50,000 Virgin Points (courtesy of Virgin Red Limited).
